Raechelle Bowlay-Sutton is Coordinator of the San Luis Obispo County Child Care Planning Council. She has worked for the past 4 years to build a cohesive and strategically designed Quality Rating and Improvement System for San Luis Obispo County as the local Quality Counts Administrator, and she also holds the unique role of the county's Assessment and Professional Development Lead. Bowlay-Sutton's background includes working with children with special needs, supporting nonprofit organization management, and owning a family child care home.

Kevin McCarty was elected to the California State Assembly in 2014 to represent the 7th Assembly District, which includes Sacramento, West Sacramento, and parts of unincorporated Sacramento County. He serves as Chair of the Assembly Budget Subcommittee on Education Finance, which oversees the largest component of California's multibillion-dollar budget. As Chair, McCarty made historic investments in public education, early childhood education, and career technical education, and increased the number of students enrolled in California's Community College, CSU, and UC systems. Other legislative priorities for Assemblymember McCarty include: expanding health care access, fighting climate change, championing criminal justice reform, curbing gun violence, tackling poverty, and advocating for the middle class. Previously, McCarty served on the Sacramento City Council from 2004 to 2014. He received an M.P.P. in public policy and administration from CSU Sacramento and a B.A. in political science from CSU Long Beach.
